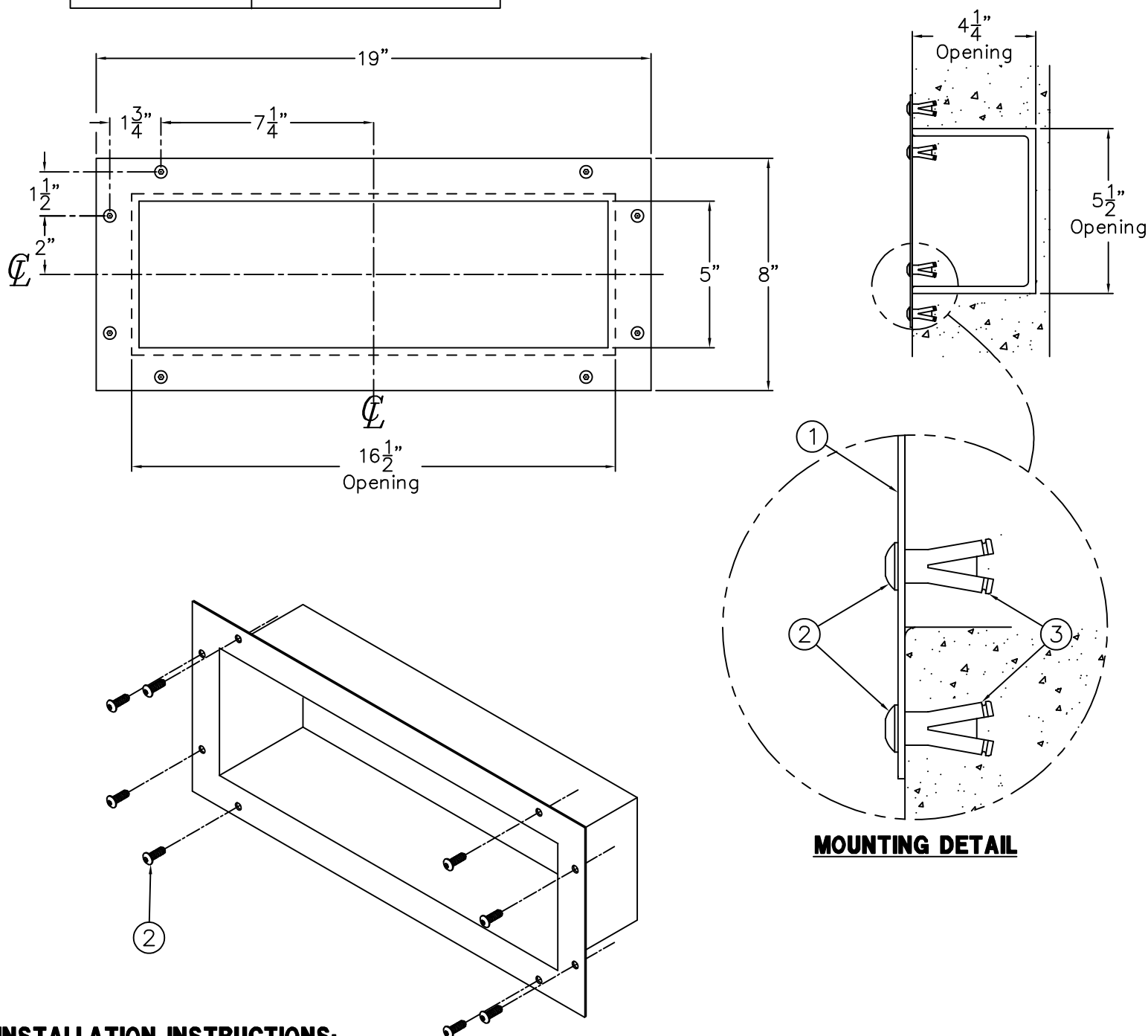

**MOUNTING DETAIL****INSTALLATION INSTRUCTIONS:**

- A- INSTALLATION REQUIRES A ROUGH WALL OPENING APPROXIMATELY 16-1/2" X 5-1/2" AND 4-1/4" DEEP TO ACCOMMODATE RECESSED SHELF.
- B- DRILL HOLES FOR WALL ANCHORS (BY OTHERS). INSTALL ANCHORS.
- C- SECURE PAPER HOLDER TO WALL USING 1/4"-20 UNC SCREWS.

- ① RECESSED SHELF FLANGE
- ② 1/4"-20 UNC SCREWS (PROVIDED)
- ③ APPROPRIATE WALL ANCHORS (PROVIDED BY OTHERS).
